III. Treasurer Update: Mikayla

- a. Financial report thru 9/8/25
 - We ended the fiscal year 7/1/25 with \$73,000 in the PTO account. Last year we projected to bring in \$55,000 from fundraising but we actually brought in \$70,000. This year's projection is to bring in \$62,000 from fundraising.
 - Big spending last year was for Art & PE (school electives) with a proposed increase this year.
 - One additional increase is for the Principal's Discretionary Fund, with an increase from \$2000 to \$2500.
 - Proposed Estimated expenditure is \$99,000 through the end of the school year. This will include a new addition: Funding \$15,000 toward field trips in a similar way we fund teacher disbursement. Possibly doing a flat rate per student (ie \$36 per student), the details are still being figured out.
 - This would leave us with a reserve of \$30,000.
- b. Approved budget for 2025-2026 school year
 - It was suggested to make a social media post sharing how the PTO money is funding PE and Art enrichment.

IV. Principal Holley Report:

- a. The "Read On, Sonoma!" Assembly last week started the program for the year. Kids are excited about the prizes.
- b. Mr. Holley did the rules round up reviewing the school rules with students.
- c. Back to school night was a success and the PTO Pool Party at Finley had a great turnout.
- d. September is Attendance Awareness month.
- e. Last year we only had 1 TK class, now we have 2 1/2 TK classes.
